



## **SUPER SUMMER CAMP 2004 Teen/Parent Agreement Letter**

**Please read the following carefully.**

Your participation as a Youth Service member (YS) is a critical element of the Army's commitment to improve family programs, particularly the Youth Services Program. Your attendance at the Hanau/Buedingen Super Summer Camp 2004 Program indicates your desire to become more involved in the Youth Program at your installation.

The Teen/Parent Agreement Letter is an overview of policy, a set of standards, and behavioral expectations to be followed by all participants, facilitators and staff. It provides the guidelines for your summer experience. Inability to follow these guidelines will result in the individual's appearance before a Review Board comprised of teens and YS staff. The Review Board will make recommendations for consequences. If it is recommended that a teen be sent home, parents will be responsible for transportation from the camp location to their home. The Installation Command will be notified as well.

The provisions set forth in this Teen/Parent Agreement are not all inclusive. Participants will have an opportunity for input to a comprehensive set of behavior expectations during the Opening Sessions of all the Hanau/Buedingen Super Summer Camp Programs.

**I agree as a participant in the Hanau/Buedingen Super Summer Camp Program, to observe the following guidelines:**

1. Be courteous and respectful toward others. Use language and manners that will bring respect to the Hanau/Buedingen Super Summer Camp Program and all of its participants. Be responsible for knowing what language and behavior is appropriate.
2. Dress appropriately at all times. Revealing clothing or apparel featuring profane language, obscenities, alcohol, tobacco, and other drug messages are prohibited.
3. Attend and actively participate in all sessions and activities sponsored by the Hanau/Buedingen Youth Services Program. Only the most extenuating circumstances will excuse a participant from participating in activities. I agree to notify my Hanau/Buedingen Youth Services Program point of contact if I am ill or cannot participate.
4. Remain at the site of the event for the duration of the program. Use of private operating vehicle or rental car is prohibited.
5. Conduct myself in a professional manner at all times. Treat program areas, and transportation vehicles with respect and care when participating in any event. Be responsible for any damage, theft, or misconduct.

6. Do not use any alcohol, tobacco, or other drugs at any time during the Hanau/Buedingen Super Summer Camp Program.
